

Agreement for Professional Clutter Clearing Practitioner Training led by Karen Kingston & Richard Kingston

This Agreement ("Agreement") is made and entered into by and between Clear Space Living Ltd of 27 Regent Grove, Holly Walk, Leamington Spa CV32 4NN (hereinafter referred to as the "Trainers") and

(hereinafter referred to as the "Trainee").

It is agreed between the two parties as follows:

1. Training

The Trainers agree to provide tuition in the form of Part One of the Professional Clutter Clearing Practitioner Training ("Training") to the Trainee during the period 6 April 2024 to 26 April 2024, after which the Trainers will assess the Trainee's eligibility to be invited to take Part Two of the Training during the period 1 May 2024 to 30 September 2024. The Trainers' decisions with regard to the Trainee's eligibility to take Part Two and be certified as a Clear Space Living Clutter Clearing Practitioner ("Practitioner") upon completion of Part Two of the Training shall be final and absolute.

2. Copyright

The Trainers warrant that they are the exclusive owners of all intellectual property in the Clutter Clearing Practitioner Training Manual ("Training Manual"), with the exception of specific sections that are published with the express permission of other copyright holders. No part of the Training Manual or subsequent training material

taught by the Trainers to the Trainee may be copied, shared, sold, taught to others, or in any way reproduced by the Trainee, including but not limited to printed, verbal, electronic and multi-media reproduction.

3. Recording

Audio, video, photographic, and other forms of recording any parts of the Training taught by the Trainers are not permitted by the Trainee.

4. Confidentiality

The Trainee agrees not to share the Training Manual or discuss with anyone who is not a Trainee or Practitioner of the Clear Space Living School of Clutter Clearing ("School") any information shared during the Training or any posts made to the virtual message board of the School. It is understood that any breach of this will result in termination of membership of the School, certifications awarded by the School, and access to the virtual message board.

5. Certification

Participation in the Training does not authorize the Trainee to claim to have been trained or certified by the Trainers in any way unless the successful completion of Parts One and Two of the Training has been attained and certification as a Practitioner has been awarded to the Trainee by the Trainers. To maintain certification status, the Trainee will be required to adhere to the Clear Space Living School of Clutter Clearing's Code of Ethics and to complete Continuing Professional Development according to the prescribed standards set each year by the Trainers.

6. Clutter clearing services

After certification as a Clutter Clearing Practitioner, the Trainee may advertise themselves as having been trained by Karen Kingston and Richard Kingston, providing that the services they provide use the primary methods taught in the Training and their skills are maintained through the completion of annual Continuing Professional Development training.

7. Space clearing services

After certification as a Clutter Clearing Practitioner, the Trainee agrees not to provide any kind of space clearing, energy clearing, or similar services to properties, or to make any claim or implied claim in advertising or promotional material to have been

trained by the Trainers to offer such services. This condition can only be revised upon successful completion of Karen Kingston and Richard Kingston's Professional Space Clearing Practitioner Training. Infringement of this condition will result in the immediate revocation of any certifications awarded by the Trainers.

8. Teaching

After certification as a Practitioner, providing certification is maintained according to the terms of Clause 5 of this Agreement, the Trainee may give talks about clutter clearing up to a maximum of one hour based on the information in Karen Kingston's book, *Clear Your Clutter with Feng Shui*. The Trainee agrees that they are not authorized to teach any form of clutter clearing courses, seminars, workshops, or similar events that are based on the teachings of the Trainers, or to train clutter clearing practitioners according to the clutter clearing methods taught by the Trainers unless they have graduated from the relevant teacher training programme taught by the Trainers.

9. Dispute

In the event that any dispute or controversy arises in connection with the Agreement, or the enforcement or interpretation of it, all legal proceedings, regardless of the amount or type of relief sought, shall take place in the jurisdiction of England and Wales and shall be governed by the laws of England. The parties to this Agreement agree to undergo mediation prior to the filing of any legal action. Should any party to this Agreement institute any action or proceeding to enforce any provision of this Agreement or any other judicial remedy, the prevailing party shall be entitled to recover from the losing party all costs and expenses incurred in any such action or proceeding, including but not limited to its reasonable mediation and legal fees.

10. Cancellation

In the event of the Trainee being unable to participate in or complete Part One or Part Two of the Training for any reason, refunds will be made according to the Booking Terms and Conditions stated on the clearspaceliving.com website.

11. Changes to this Agreement

Any changes, additions, stipulations or deletions including corrective lining out by either party will not be considered agreed to or binding on the other unless such

modifications have been initialled and approved in writing by the other.
